

Joint Technology Committee of COSCA and NACM Court Technology Standards

This version of the JTC Court Technology Standards matrix excludes information exchange specifications that were included in previous versions of the matrix. With the dynamic nature of exchange specifications and with many different versions of specifications developed, the JTC has elected instead to continue support of, and participation in, NIEM and Global initiatives for justice information sharing without formal review and approval of each specification. Information Exchange Package Documentation (IEPDs) and Global Service Specification Packages (SSPs) are available through external sources listed below. JTC will still consider adoption of information exchange standards that conform to NIEM and the GRA while specifically addressing a court business function or problem (for example, ECF standards for e-filing).

- Hold Approval process is on hold for clarification, changes based on feedback, or other reasons as determined by the JTC.
- Recommended Formal reviews have been completed. The JTC has voted to recommend the standard for adoption.
- Adopted COSCA and NACM boards have voted to approve the standard for adoption.
- Rejected The standard was determined inadequate or unnecessary and rejected by the JTC and/or COSCA and NACM boards.
- Superseded Standard has been replaced by a newer version or another standard or determined to be unnecessary.
