 - o Jessica will screen-share boundaries and guidelines
- Jessica will share with attendees how to participate via Zoom
 - o Jessica will screen-share visual instructions
 - Q/A's will be read on behalf of the submitter (if their name is identified it will be read as well)
 - Raised Hands will be called on in the order that they are raised (must keep their hand raised to keep spot in line). Sheriece will identify who will be promoted into the room to share for 1-2 minutes comments/questions

 - Spotlight added to the responding Chief - both participant and chief will be visible
 - John will thank the speaker and ask for the next speaker
 - **SPEAKER 2** will be demoted and spotlight removed from Chief
- Sheriece will identify **SPEAKER 3** with several questions and admit into the room
 - Angel will ask **SPEAKER 3** to read all questions at once and explain several Chiefs will respond to try and address the questions
 - Spotlight added to **SPEAKER 3**
 - Angel will direct the questions to the Chief Justices of BMC, District, Superior courts to respond
 - Spotlight added to responding Chief
 - Angel will thank the participant and ask for next speaker
 - **SPEAKER 3** will be demoted, spotlight removed from Chief(s)
- Sheriece will identify **SPEAKER 4** on re-entry and admit into the room
 - John will introduce **SPEAKER 4**
 - Spotlight added to **SPEAKER 4**
 - John will direct the question to Commissioner Dolan
 - Spotlight added to Commissioner Dolan
 - John will thank the participant and take next comment
 - **SPEAKER 4** will be demoted and spotlight removed from Commissioner Dolan
- Sheriece will identify **SPEAKER 5** on CORI and admit into the room
 - Angel will ask **SPEAKER 5** to make his comment/question
 - Spotlight added to **SPEAKER 5**
 - Angel will ask if any chief or the commission wish to respond
 - Spotlight added to responding Chief/Commissioner
 - Angel will thank the speaking participant
 - **SPEAKER 5** will be demoted and spotlight removed from Chief/Commissioner

- Sheriece will identify **SPEAKER 6** and admit into the room
 - o John will field this question/comment
 - Spotlight added to **SPEAKER 6**
- John will ask if any chief or the commission wish to respond
 - o Spotlight added to responding Chief/Commissioner
- John will thank the speaking participant
 - o **SPEAKER 6** will be demoted and spotlight removed from Chief/Commissioner
